I crewed 45 missions as plane captain, returned stateside 1945. Assigned Hutchison, Ks. for retraining on PB4Y-2. After VJ day I was re-assigned to USS Norton Sound AV-11, PBM aircraft for first exploration to Polar area, 1946 reassigned to reserve training center Los Alamitos NAS. Separated US Navy, enlisted USAF 452nd Bomb Wing B-26 aircraft

Who is a voting member? by Vic Gulliver

Can Spouses Vote in our Business Meetings?

There might have been some confusion at our reunion business meeting on the issue of voting. The question was whether or not spouses of members are allowed to vote in our meetings. The short answer is "yes they are." Here is the background on that:

The VP-2 Association is a veterans' charitable organization with tax advantages as defined by the IRS. To obtain and keep that status, our membership must consist of at least 90% war veterans. We do meet that standard. Our Association by-laws define members as "those persons who have served in Patrol Squadron Two and who are either veterans or war veterans as defined by IRC 170(c)(3)." Our by-laws also define Affiliated Persons as "family members of veterans and other persons of high moral character who have an abiding interest in supporting the purpose of the Association." Our by-laws stipulate that "Affiliated Persons may be invited by the Executive Board to participate as members."

So, while spouses are not officially "members" of the Association, spouses have been invited to participate as members in such matters as attendance at reunions, voting in business meetings, and in whatever else the members do. Spouses of active members do not pay separate dues, and widows of former members do not pay dues.

Chaplain's Corner by Doug Millar

Greetings! It was great to be with many of you at our reunion last August at Whidbey. A good time was had by all and if you missed it we hope you can make the next one in 2018.

Shortly after the reunion my wife and I had the pleasure of going to England for a few days in London, followed by a few days in Cornwall. At the end of that visit we did something which has been on my "Bucket List" for many years - that being to get on a ship in Southampton, England, and cross the Atlantic Ocean to New York. So on October 18 we boarded the Queen Mary 2 and transited to the US. My father had immigrated to the US through Ellis Island in 1904 and I had always wanted to follow the path of that crossing.

As you can imagine, everything on the QM2 was beautiful and extremely well done. I'm sure that our accommodations had no semblance whatsoever to those that my dad experienced, to say nothing of the food. Believe it or not, there was no battleship gray paint anywhere!

There were many highlights on that crossing, but for us one of the most memorable was the Sunday morning interdenominational church service held onboard and attended by a large number of passengers. The service was led in its entirety by the Captain of the ship, a long time sailor with the Cunard Line. He began the service by saying, "Holding Sunday morning services is a tradition in the Royal Navy that goes back to the days of sail. The Captain of the ship was not only responsible for the safety and discipline of the entire crew, but also for the spiritual lives of the men. Therefore, due to the fact that the ships did not carry a priest, it was the responsibility of the captain to conduct Christian services for the crew. It is a tradition which carries on today and is honored here on the Cunard Line." He went on to conduct a full service with many hymns, prayers, and scripture lessons. Very interesting to me is the fact that the English are not afraid to pray in the name of Jesus, nor to talk about Jesus as our Lord and Savior. Obviously they don't have the ACLU in England!

Upon our arrival in New York my wife and I went to Ellis Island (in the middle of New York Harbor just next to the Statue of Liberty). The entire island has been turned into a national monument and the facilities have been restored to be as they were in the early 1900s. It became very clear that this port of embarkation into the US was not only a place of joy and freedom for many, but also a point of extreme heartbreak and sorrow for others who were refused entry due to their health, and returned back to Europe as separated and broken families. Can you imagine the crushing emotional blow that this was to so many of those people, who after years of dreaming and saving to go to America found themselves being rejected and turned back to their lives of suffering?

Perhaps you have suffered such a blow - through the loss of a spouse, or the rejection of a lover, or perhaps a financial setback of monumental proportions, or the loss of your health and mobility. I'm sure that many of those who were turned back from Ellis Island fell back on their faith in Jesus Christ to help them through such terrible times.

Christ is just as available today for us in our times of need (as well as plenty) as He was then. The Bible tells us, "Jesus Christ is the same yesterday, today, and forever." (Hebrews 13:8) Christ also said, "Come unto me, all who are weary and heavy-laden, and I will give you rest." (Matthew 11:28) Whether we are in good times or horrible times in our personal lives, Christ is yearning for us to come to Him. "Seek the Lord while He may be found; call upon Him while He is near." (Isaiah 55:6) So often I find that the last thing that I do when I am upset over something is to take it to the Lord in prayer. Let's endeavor to turn to Him more easily - whether in times of need, or times of gratitude.

Christmas is soon upon us. Have a most blessed season!
